

- iv) Training on tips for assessing the quality of OER
- v) Convert final semester projects by students into papers where the mentor can co-author with students
- vi) Create informal communities to encourage peer-to-peer mentoring because NCDOE students are from various industries and can benefit from each other.
- vii) Develop quality assurance for online course.
- viii) Present the research work undertaken by faculty in the upcoming meeting.
- ix) Equip the NCDOE team with Digital Education Polict 2020.
- x) Analyse the question papers of past years and how students performed in those questions. This will help in improving assessment tools and grading processes. The data can be fed into teaching also.
